To ensure the safety of motorists on Virginia's highways, drivers must meet certain requirements including vision, medical and mental standards.

Overall medical review requirements are based on the Code of Virginia as well as guidance from DMV's Medical Advisory Board.

Medical Advisory Board

Seven members:

- Appointed by the Governor
- Licensed physicians
- Currently practicing in Virginia

DMV's Goals

 Allow people to drive for as long as they can drive safely.

Ensure that drivers and pedestrians are safe.

Reviewing Drivers

- DMV does not base driving on age but on function
- Each case is evaluated on its own merits
- DMV identifies drivers for review by
 - Driver's license applications
 - Reports of impaired drivers



Motor Vehicles



Driver's License Application

Medical questions on the DMV application inquire about:

- Vision conditions
- Physical and/or mental condition that requires medication
- Seizure, blackout or loss of consciousness
- Condition that requires the use of special equipment to drive


Reports of Impaired Drivers

DMV receives reports from:

- Law enforcement
- Physicians
- Courts
- DMV representatives
- Relatives
- Concerned citizens
- The Driver

Reports of Impaired Drivers

Statutes that encourage reporting of impaired drivers:

- Virginia Code § 46.2-322
- Virginia Code § 54.1-2966.1

DMV accepts reports by mail or fax





Reports of Impaired Drivers

Information needed



- Identifying information about the driver
- Reason why reporting person is concerned
- Relationship to the driver
- Signature of person making the report (for letters and DMV report forms)
- Contact information for the reporting person

DMV takes the following actions after receiving a report:
Step 1: Review report on impaired driver
Step 2: Follow up with the person reporting a driver, if necessary
Step 3: Determine the types medical review

requirements to be imposed, if warranted

- Types of Review Requirements:
- Medical report
- Vision report
- Knowledge test
- Road test
- Driver evaluation

Step 4: Notify driver of requirements

- Driver is given 30 days to comply with initial requirements
- Driver is given an additional 15 days to pass tests, if required, after medical/vision reports

Step 5: Evaluate all information provided and test results
Step 6: Determine if additional information or tests are needed
Step 7: Review case with Medical Advisory Board, if necessary

Step 8: Determine next action(s)

- End medical review (no further requirements/action needed)
- Impose appropriate driver's license restriction(s)
- Require periodic medical/vision reports
- Suspend driving privilege

Medical Review Hearings

- A driver may contest the action taken by DMV and request an administrative hearing
 - Must be requested in writing
 - Scheduled and conducted by the DMV Hearings Office

The Mature Driver

- DMV offers many different programs, services, and safe driving tips to meet the changing needs of mature drivers
- Mature drivers are twice as likely to be hospitalized because of a crash than any other age group resulting in an average of 6.3 days in the hospital at an average charge of \$37,500.

The Mature Driver

- The likelihood of hospitalization or death of drivers involved in a crash increases with age
- Drivers 85 years old and over are 5 times more likely to be hospitalized and 8 times more likely to die than the youngest age group (15-20) when involved in a crash

The Mature Driver

- In 2011 (in Virginia):
 - There was a total of 7262 injuries for drivers ranging in age from 61 – 70+
 - -There were 161 fatalities in the same age and gender range
 - There were 118 driver & passenger fatalities in the same age and gender range

Driving and Rx Drugs


- Avoid driving if you're not sure how a drug will affect you
- Take medications only at prescribed levels and dosages
- Do not drive when you feel ill, tired or disoriented
- Never combine medication and alcohol while driving

Rx Drugs (cont'd)


- Consult with your doctor or pharmacist about medications that may impair driving
- In case of an emergency, carry a list of all medications you are taking, including names and dosages

- Generally requires a physician referral





2007 NHTSA Study:

Medical Review Process and License Disposition of Drivers Referred by Law Enforcement and Other Sources in Virginia

July 2011







NHTSA Study

- 2007: NHTSA sponsored project to develop an intervention to increase law enforcement referrals
- Project described the medical review process outcomes of 100 drivers referred by law enforcement (LE)
- 105 drivers referred by 7 other sources

NHTSA Study Driver Age and Gender: Referred drivers ages: 17 – 94 - 49% Male - 51% Female

Highest percent of referred ages:

-70 - 79 (23% of the sample)

6% of state population is 70-79

-80+(24% of the sample)

3% of state population is 80+

NHTSA Study

Research Findings:

- Those who refer medically at-risk drivers to the VA DMV provide a valuable public safety service
 - -Majority were quality referrals
 - Non-quality referrals may serve as data for the future if those drivers become crash involved or are referred again

NHTSA Study

Research Findings (continued):

- Inform and educate adult children of medically at-risk drivers
- Inform and educate physicians
- Inform and educate prosecutors and judges
- Red Flags of Medically At-Risk Older Drivers
